PARENT GOVERNOR OPPORTUNITY

I am writing to you to invite you to stand for election as a parent governor/trustee for Stewards Academy.

Governance is a challenging and demanding role, but also a very rewarding one. As a trustee serving on the Stewards Trust Board, you would work in partnership with the headteacher, the senior leadership team, and co-operatively with other trustees to raise standards and improve outcomes for all children in our school.

This is a voluntary position, but there are many reasons why our trustees find their roles rewarding.

For example:

- Trustees contribute to raising standards of education in our school, making a positive difference to the lives of young people now and in the future.

The appendix to this letter summarises the circumstances under which someone cannot serve as a trustee. Nominations must be from parents or carers with children at the school on the day that nominations close. All offers of appointment will be made subject to DBS clearance.

To apply, please complete the enclosed nomination form and return it to the Headteacher's PA, Mrs Souter either by emailing <u>dsouter@stewardsacademy.org</u> or returning the form in a sealed envelope to the school office marked 'Parent Trustee Application' no later than 4pm on **29th September 2023.** Please also include a short personal statement to support your nomination, which should be no longer than 200 words.

If several applications are received, all parents / carers will be sent a ballot paper via their young person and asked to vote. The personal statements of the candidates will be printed alongside their names on the ballot paper. Each parent is entitled to one vote. The ballot will be secret, and you will











be notified of the result as soon as possible afterwards. A vote will only be necessary if more than one application is received; if only one application is received, the candidate will be appointed unopposed.

APPENDIX: SUMMARY OF WHEN SOMEONE CANNOT SERVE AS A TRUSTEE

A trustee must be aged 18 or over at the time of their election or appointment and cannot be a registered pupil at the school.

A person is disqualified from holding or from continuing to hold office as a trustee if they:

- fail to attend meetings without the consent of the trustees for a continuous period of six months, beginning with the date of the first meeting missed (not applicable to ex officio trustees);
- are subject to a bankruptcy restriction order, an interim bankruptcy restriction order, a debt relief order or an interim debt relief order;
- has had their estate sequestrated and the sequestration order has not been discharged, annulled or reduced;
- are subject to:
- i) a disqualification order or disqualification undertaking under the Company Directors Disqualification Act 1986
- ii) a disqualification order under Part 2 of the Companies (Northern Ireland) Order 1989
- iii) a disqualification undertaking accepted under the Company Directors Disqualification (Northern Ireland) Order 2002
- iv) an order made under Section 492(2)(b) of the Insolvency Act 1986 (failure to pay under a County Court administration order);
- v) have been removed from the office of charity trustee or trustee for a charity by the Charity under section 178 of the Charities Act 2011;
- vi) are included in the list of people considered by the Secretary of State as unsuitable to work with children; · is disqualified from working with children or subject to a direction under Section 142 of the Education Act 2002;
- vii) are disqualified from registration for childminding or providing day care;
- viii) are disqualified from registration under Part 3 of the Childcare Act 2006;
- ix) have received a sentence of imprisonment (whether suspended or not) for a period of not less than 3 months (without the option of a fine) in the 5 years before or since becoming a member/trustee/local governor.
- have received a prison sentence of two-and-a-half years or more in the 20 years before becoming a member/trustee/ local governor;
- xi) have at any time received a prison sentence of five years or more;
- xii) have been fined for causing a nuisance or disturbance on school premises during the five years prior to or since appointment or election as a member/trustee/local governor;
- xiii) refuse to allow an application to the Disclosure & Barring Service for a criminal records certificate.

An enhanced DBS check will be carried out by the school.

Stewards Academy has a duty to provide information to the DfE for inclusion on the national governors' database. There is also a requirement to publish information on the school's website.
