

Stewards Academy Scheme of Delegation

The phrases used in the context of this document have the following meanings:

Consult: The individual or group who should be consulted by the Trustees as part of the process of completing the task.

Deliver: The individual or group that has responsibility for undertaking the particular task delegated to them and reporting on its delivery

as appropriate.

Monitor: The group that has responsibility for monitoring whether a particular task is being carried out to a satisfactory standard.

Recommend: The individual or group that should make recommendations as to how a particular task should be completed. The CEO,

Executive Head, CFO and Finance, Audit & Risk Committee will make recommendations to the Trust Board.

Ratify: Final ratification of policies or recommendations made by the CEO, Executive Head, CFO or Finance, Audit & Risk Committee to

the Trust Board (in cases where powers have been delegated by the Trust Board).
